Brian Jordan discussed public comments on behalf of Michele Stucky concerning an Eagle scout project and the installation of a kayak kiosk at the boat ramp.

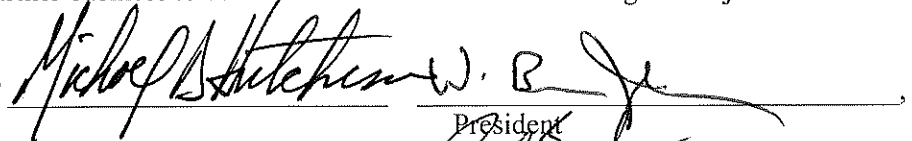

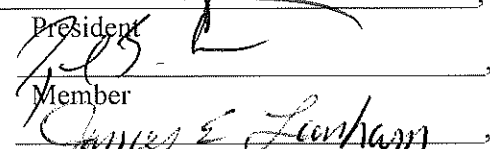
Jim Lanham made a motion to approve the installation of a kayak kiosk at the boat ramp. Paul Coffman seconded the motion. Voted and passed.

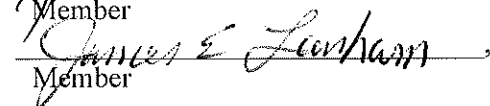
Jim Lanham made a motion to adjourn. Paul Coffman seconded the motion. Voted and passed.
