Ingrid Barce discussed a change the fair board is requesting on the lease agreement with the town. Council tabled.


Ingrid Barce discussed Slauter Lane and proposed a survey be done for this property, as well as Park Avenue, and the fairgrounds. Council ok with this.


Ingrid Barce discussed public records request and amending the town's current ordinance on the records request.


Paul Coffman made a motion to adjourn. Jim Lanham seconded the motion. Voted and passed.
